### 5) OTHER BUSINESS

- B. Proposed Annual PHA Plan was presented as attached. As requested, Ms. Conner explained that CIRHA will not be submitting a "Registration of Interest" to HUD for Veteran's Affairs Supportive Housing (VASH) vouchers. Each "Registration of Intent" must include a letter of support from a partnering VA facility. Due to there being no VA facility in the CIRHA service area, CIRHA is not able to obtain a support letter.
- C. Vanessa Baker-Latimer stated that she thought the Commissioner Retreat held in March 2018 was very informative and helped her reflect on her position as a board member.
- D. The City of Urbandale, Iowa has agreed to enter into a 28E Agreement with CIRHA. This will allow CIRHA to administer tenant-based section 8 housing assistance within the City of Urbandale, Iowa located in Dallas County. The City of Urbandale has been in contact with Todd Kilzer about appointing him as their representative on the CIRHA Board of Commissioner's. This appointment would result in there being two Executive Committee Officer's from Dallas County which is not allowable by CIRHA Bylaws. Therefore, Todd Kilzer or Paul Thompson would be required to step down as an Officer. Paul Thompson agreed to step down as Treasurer and become the Dallas County Alternate Representative. The Treasurer position has become vacant; Ms. Conner will look into temporarily filling the Treasurer position until the next annual meeting.
