Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form. Note: PHAs with zero public housing units must continue to comply with the PHA Plan requirements until they closeout their Section 9 programs (ACC termination).

Definitions.

- (1) **High-Performer PHA** - A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

Modernization or Development.

The PHA has received 311,540 for the 2026 Capital Fund Grant which it will use to: update spaces and equipment at the central office building, replace two maintenance vehicles, and modernize bathrooms, repair concrete, remove dead trees posing safety concerns, update roofing, facia, soffit and gutters at public housing properties.

Units with Approved Vacancies for Modernization.

B.3 Progress Report.

GOAL 3: The PHA employs a full-time FSS Coordinator who administers a successful HCV Family Self-Sufficiency Program that averages 40 participants with average escrow of \$1,500 and had 11 graduates in fiscal year 2025. The Executive Director and FSS Coordinator partner with supportive service agencies and community organizations by attending quarterly meetings. GOAL 4: The PHA ensures equal opportunity and affirmatively furthers fair housing by: taking affirmative actions to ensure access to assisted housing regardless of race, color, religion, sex (including sexual orientation and gender identity), national origin, disability, and familial status. All PHA Staff completed Fair Housing Training in June 2025. GOAL 5: The PHA has maintained its High Performer Status in the HCV Program and performed well on Public Housing NSPIRE. The PHA continues to employ a highly trained, informed and motivated staff. The PHA's new Executive Director provides transparent, timely, and proactive communication that aid the Board of Commissioners to make informed decisions. The Executive Director participates in forums and meetings with stakeholders in served communities. GOAL 6: The PHA continues to make progress with educating public housing residents on lease requirements such as maintenance and rent payment. The PHA scored 96/100 on it's first Public Housing NSPIRE and on average 3/132 residents have a one-month rent balance at the EOM.
